SPECIAL MEETING - JUNE 14, 2010

On the 14th day of June, 2010, there was an Special Meeting of the Commissioner' Court in the Courthouse, Rockport, Aransas County, Texas, with the following members present: C. H. Friebele, County Clerk.

PRESENTATION - ARANSAS COUNTY HISTORICAL SOCIETY

Janie White, President of the Aransas County Historical Society, told the Court the Historical Society had worked on the photo project for two (2) plus years. The Commissioners' Court funded the project in 2007. Bay Survey put the photos on an aluminum surface that can be cleaned easily using commercial glass cleaner. The Commissioners' were also presented with an album which included historical photographs.

SPRINGFIELD PROJECT - CHAMBER OF COMMERCE

2010 BUDGET

County Auditor Kirk presented several reports on the status of the budget. She told the Court that 65% of the budget is salaries and perks. She recommended the Court initiate a hiring freeze. Kirk's information, Commissioner Ms. of interjected that the County has a \$250,000.00 shortfall at this time not the \$1M they were told last week. Commissioner Chaney complained to County Treasurer Oliver because her personnel deputy was not present at the meeting to answer questions regarding the possible cost savings if the County did initiate a hiring freeze. Both Commissioner Chaney and Commissioner Smith suggested the County may have to cut salaries in order to balance the budget. Commissioner Smith stated he would not be in favor of raising taxes again this year.

Motion was made by Commissioner Smith and seconded by Commissioner Murph to table any action on the 2010 budget at this time.

PERSONNEL POLICY CHANGE
