**NOTICE:** Aransas County has received notice of a date and time for a special meeting of the **Aransas Pathways Steering Committee** with presentations of needed connections of major trails to sites identified by the sub-committees: history, birding, trail coordination, signage, kayaking and wade fishing, biking, etc., and ID of any other interest groups which should be considered. Real estate acquisition advisors will be on hand. There will be discussion of the inventory of needs which will be later prioritized and then move forward with County, TxDot, granting agencies, etc. It will include needed access to publicly owned lands, needed private land for purchase or easement, and basic and expanded needs for each site, with a goal of completing this listing by October 1, 2011. This meeting will be from 5:30 to 6:30 pm at 81 Griffith Drive, Rockport, Texas.

Additionally, **The Aransas First Board of Directors Meeting** will meet at the same location starting at 6:30 pm, and the agenda includes presentation of the major trails proposed in the county by area, for example Lamar. Each Aransas Pathways sub-committee designee will then be asked to briefly note their sites in that area, basic needs, how they can be linked if possible, and record any changes to the preliminary plans. The areas are:

Lamar and north, North Peninsula (Copano bridge to 3036), 3036 to Market St., Market to 16<sup>th</sup> St., 16<sup>th</sup> St., to 188, 188 to Aransas Pass, -- (most of these are west of Bus. 35), Fulton area east of Bus. 35, Rockport east of Bus. 35, Fulton to Beach Park and Harbor, and Rockport downtown area south to Cove Harbor

Pathway sites should be organized so they can be quickly presented to the Board in this geographic sequence, and also advise of any catchy names for trail loops in these areas. Discussion of new ideas, sites, and issues will be at the end of the meeting, and there will be a large amount of material to cover in a short time. This process should help integrate all our hard work and will perhaps stimulate new ideas from a mixed audience of persons not so closely involved with one pathway to share with the different committees and to each other.

Spouses are welcome to come, and hamburgers and chips will be served for the group at 6:30 pm. A quorum of County Commissioners may be present.
