If you wish to enter a plea of “NOT GUILTY” and desire a trial, you must so indicate in the proper space provided on the reply form on the reverse side. The Court will notify you of when you **MUST** appear for trial. You have the right to a trial by Jury, if you so request.

If you wish to enter a plea of “GUILTY” or “NOLO CONTENDERE”, please indicate on the reply form on the reverse side. A plea of “NOLO CONTENDERE” means that you do not contest the state’s charge(s) against you. The fine for a “NOLO CONTENDERE” plea is the same as for a plea of “GUILTY”. Either plea indicates that you agree to waive appearance before the court for trial. Make your remittance by Cashier’s Check or Money Order payable to Judge Patrick Daly. You **MUST** return this letter and your copy of the Citation postmarked no later than the appearance date shown on the Citation.

IF YOU FAIL TO RESPOND TO THIS CHARGE BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE OF VIOLATE PROMISE TO APPEAR MAY BE FILED, WARRANTS WILL BE ISSUED FOR YOUR ARREST AND ADDITIONAL FEES ASSESSED. YOU MAY ALSO BE DENIED THE RIGHT TO RENEW YOUR DRIVERS LICENSE. The minimum fine for “VIOLATE PROMISE TO APPEAR” IS \$250.00 plus Court costs.

All fines and court costs are deposited in the County Treasury, the Justice Courts of Aransas County
are paid a salary and receive no percentage of fine payments
