<i>Filing Requirement per Property Code 12.001(b) and 12.001:</i> Instruments must have original signature and proper acknowledgement		
<i>Filing Requirement per Local Government Code 193.012:</i> After recording, original documents shall be returned to the person who filed them.		
<i>Filing Requirements and Specifications per Property Code 11.03(2):</i> Instruments conveying an interest in real property that do not include the mailing address of each grantee shall be subject to a penalty filing fee equal to the greater of \$25 or TWICE the statutory recording fee for the instrument paid.		
<i>Filing Requirements and Specifications per Local Government Code 191.007(b-g):</i> (b) A page is considered to be one side of a sheet of paper. A page must: (1) be no wider than 8-1/2 inches and no longer than 14 inches; (2) have a sufficient weight and substance so that printing, typing, or handwriting on it will not smear or bleed through; and (3) be printed in type not smaller than eight-point type and be suitable otherwise for reproducing from it a readable record by a photocopy or photostatic or microphotographic process used in the office of the county clerk. (c) Except as provided by Section 11.008(c), Property Code, a clearly identifying heading, similar to the headings on most commercially supplied printed forms, must be placed at the top of the first page to identify the type or kind of legal paper. (d) Printing, typing, and handwriting must be clearly legible. (e) Names must be legibly typed or printed immediately under each signature. (f) All photostats, photocopies, and other types of reproduction must have black printing, typing, or handwriting on a white background, commonly known as positive prints. (g) Riders and attachments must comply with the size requirement prescribed by Subsection (b) and shall not be larger than the size of the page. Only one rider or attachment may be included in or attached to a page. <i>Instruments that fail to meet any of the recording requirements shall be subject to a penalty of TWICE the regular filing fee or recording fee provided by statute for that page.</i>

FEES FOR VITAL RECORDS

Plain Copies may NOT be issued for Vital Records. Vital records, such as birth or death certificates, are legal documents that are used to prove a person's identity. **To get a certified copy of a vital record, you must be a person qualified to do so and submit a completed application** which includes acceptable identification, the correct fees, and, in some cases, supporting documentation.

Birth records are closed to the public for 75 years. Likewise, death records are closed for 25 years.

Texas Family Code 2.003 states: **A person under the age of 18 years of age may not marry UNLESS the person has been granted by this state or another state a court order** removing the disabilities of minority of the person for general purposes. (effective September 1, 2017)

Per Family Code 2.201: **If a marriage ceremony has not been conducted before the 90th day after the date the license is issued, the marriage license expires** (and can no longer be used).

The County Clerk's office can provide additional marriage license information, regulations, and requirements including marriage by proxy, absent applicant, marriage to an incarcerated person, marriage of a deployed soldier, or soldier deployed to a hostile zone.

Per Family Code 2.204, there is a 72-hour waiting period from the date and time of application before the ceremony can take place. The waiting period cannot be waived unless an applicant:

- is a member of the armed forces of the United States on active duty,
- performs work for the United States Department of Defense as an employee/contract worker, or
- obtains a written waiver from a judge of a court with jurisdiction in family law cases, a justice of the supreme court, a judge of the court of criminal appeals, a county judge, or a judge of a court of appeals.
