
NOW, THEREFORE, NOTICE IS HEREBY GIVEN that on Tuesday, May 5, 2015, the foreclosure sale will be conducted in Aransas County in the area designated by the Commissioners Court, pursuant to Section 51.002 of the Texas Property Code as the place where foreclosure sales are to take place. If no place is designated by the Commissioners Court, sale will be conducted at the place where the Notice of Trustee's Sale was posted. The trustee's sale will be conducted no earlier than 10:00 AM and must be concluded within three hours of such starting time. Said sale shall be to the highest bidder for cash.

Said Real Estate is described as Follows: In the County of Aransas, State of Texas:

**ORDER TO PROCEED WITH NOTICE OF FORECLOSURE SALE
AND FORECLOSURE**

Came on for consideration the Motion for Entry of Default Order Allowing Foreclosure filed by Nationstar Mortgage LLC f/k/a Centex Home Equity Company, LLC ("Applicant"), for Order for Foreclosure pursuant to Rule 736 of the Texas Rules of Civil Procedure. The Court is of the opinion that said application should be GRANTED.

The Court finds that no response has been filed and that the return of service has been on file for at least 10 days.

Pursuant to Rule 736.8(b), the Court further finds that the Petitioner has established the basis for the foreclosure and that:

(1) the material facts establishing the basis for foreclosure are as follows:

- a monetary default of the subject Note exists;
- on June 11, 2013, the Applicant gave the Respondent(s) proper Notice of Default;
- the default was not cured and the Note was accelerated on September 10, 2013;
- and
- the loan is due for the August 15, 2012 payment and all subsequent payments.

(2) The property to be foreclosed is commonly known as 1319 South Live Oak, Rockport, Texas 78382 (the "Property") which has the following legal description:
