WHEREAS, THOMAS FORSBERG and KIMBERLY URBANCZYK-FORSBERG, (the "Mortgagor") executed and delivered to F-T Service Corp., Trustee for SIDNEY H. SMITH, III, a certain Deed of Trust dated February 15, 2012, which instrument is recorded at File No. 321769 of the Official Records of Aransas County, Texas, covering the hereinafter described property; and

WHEREAS, Thomas M. Forsberg filed for relief under Chapter 13 of the United States Bankruptcy Code on April 6, 2015, under Case No. 15-20139; *In Re Thomas M. Forsberg, Debtor*; In the United States Bankruptcy Court for the Southern District of Texas, Corpus Christi Division; and

WHEREAS, an Order on Emergency Motion of Sidney H. Smith, III, to Dismiss, With Prejudice, [#25] was signed by the court on April 13, 2015, in Case No. 15-20139, permitting Beneficiary to proceed with the posting of a Notice for foreclosure sale covering the property securing the indebtedness owing to Beneficiary by Mortgagor under the above-mentioned Deed of Trust; and

WHEREAS, default has occurred in the payment of the indebtedness secured by the above-mentioned Deed of Trust, and Sidney H. Smith, III, the present Beneficiary, has instructed the undersigned Trustee to enforce the provisions of said instrument;

NOW, THEREFORE, NOTICE IS HEREBY GIVEN THAT after the posting of this Notice in accordance with the above-mentioned Deed of Trust and the law, and after giving such other notices as required by law, the undersigned Trustee, or any successor Substitute Trustee, will sell to the highest bidder for cash, or to the Beneficiary or any other holder of said indebtedness for credit, in accordance with the terms of said Deed of Trust the hereinafter described property at the County Courthouse of Aransas County, Texas, on Tuesday, the 5th day of May, 2015, the same being the first Tuesday in such month, to-wit:

Lot No. Two (2), CHINA BAY, Aransas County, Texas, according to the map or plat thereof recorded in Volume 4, Page 136, Plat Records, Aransas County, Texas.

The earliest time at which the sale will occur will be 10:00 o'clock a.m., and the sale will be conducted not later than three hours after that time, such hours being between 10:00 a.m. and 1:00 p.m. Further, the sale will be held at the front steps to the East lobby entrance of the Aransas County Courthouse, Rockport, Texas, such being in the area at the Courthouse designated by the Commissioners Court of such County where sales are to take place pursuant to Section 51.002 of the Texas Property Code.


This sale shall be subject to those reservations, matters and exceptions, if any, set forth in the said Deed of Trust to the extent such are still in force and effect.
