The Meeting was convened at **9:00 a.m**. at which time a quorum was declared by Judge Mills, WHEREUPON, the following proceedings were had and done to wit:

CITIZENS TO BE HEARD

There were none.

PRESENTATIONS

1. Agrilife Extension Office: 4-H Agriculture Showcase & Home Makers Show by Ginger Easton-Smith, Megan Glidden, and Darla Zuniga. Ginger Easton Smith: The kids had a great show this year, we had 38 kids that showed live-stock and about 30 kids that did homemaking projects of all kinds with lots of prizes awarded as a result. (Showing a Power Point) We had three entrants for the Queens contest, Kayla Ramos, Megan Leur, and

Trinity Sifuentes. Megan got first runner up, we are very proud of all of them. We also had great success in the poultry show, Megan Leur received Grand Champion with her Roaster, she also got it last year with her Roaster. Kendall Isabel received Reserved Grand Champion with her Roaster. Kinsley Knight who is new this year received Grand Champion with her Single Fryer Rabbit and Nikki Rae Allen got Intermediate Poultry Showmanship, which I think is really awesome because they are not just showing their animal, they are answering the Judge's questions, showing that they know how to raise the animal, how to feed them, and various other things. Trenton Flowers got Intermediate Rabbit Showmanship, he also received this award last year. Megan Gliddon: Kaitlin Carruth got Reserved Sweepstakes in the Clothing Division and also won the Cotton Award which the project has to be 100% cotton to receive that award and she had to write up a little thing on that to be able to win that award. Champ Kuenstler won Reserved Sweepstakes with her knife that she forged out of a railroad spike in the Handy Craft Division and that was in the recycle, repurpose section of that division. She also won the Cotton Award for some pillows that she made. Layla Flowers made a hanging quilt and won a Society Award with a dress that she made. In the turkey show there are Broilers, Roasters, and Turkeys and we had kids entering in all of those divisions. Noah Purdue, Sienna Goad, and McKayla Mills Goad showed in all of these divisions and they all have to help each other hold up the birds and transfer them around to each other while they are being judged, some of these turkeys weigh about 18 pounds. Brothers, Tyler and Ethan Gregory entered goats, we got a good picture of them walking out together. We also have two sisters

Kate and Kara Hill, in a category against each other. Other entrants shown were McKenna McPherson, Kaidra Bennett. Lexi Villa showed Lambs, and got first prize in her weight class. Jane Longino showed two different pigs entered in different classes, then we have Adam Lamb, a senior, showing his pig for the very first time. Champ and Madden Kuenstler showed steers and this is a first for steers from Aransas County in a while. There were a total of about 450 Rabbits entered in the Rabbit Show this year so that was a very long show. In the AG Mechanics Division, Megan Hillis made a hanging light fixture, Kendall Isabel made this sofa table and her cousin and brother made this dining room table, two kids made BBQ Pits. Sydney Lopez entered fourteen projects in the Homemaking Event. Madison Peterek entered a starfish cake, and two wreaths. Andrew Martin entered three pictures, he is eight years old and this was his first time entering, he did very well, one placed 6th over-all and he was fourth out of getting a belt buckle. All of these projects would not be possible without the support of Aransas County and 4-H Members, their parents, volunteers, all helping each other out.

2. Annual Profile Report related to 2018 Traffic Stops as required by Texas Commission on Law Enforcement by Sheriff Bill Mills. What I have brought to the court this morning is a report mandated by the Legislature that we report on profiling every year. This is not the complete report, what we have found when we got ready to submit it is, 2018 CJIS changed reporting guidelines which is a much more detailed report,

it's information that we have but we did not have it in the computer system. Odyssey did not update our system last year with the changes so we are having to go back manually and count through the different places where we have the information. The report before you breaks down the citations only, going forward they are going to have us list the number of warning citations that were issued as well, breaking it down by gender, the type of road it was written on, time frames of the day, it will include whether there were drugs and the types of drugs that were confiscated in the arrests that were made, it's just a much more detailed report. A lot of the stuff that we have in our Stonegarden reporting, we also have it in other reports that we accumulate but it wasn't entered into Odyssey when we put the tickets in monthly and that's generated a whole other issue with Tyler Technologies, asking why we didn't receive an updated version for the profile reports where at the end of the year we could have pushed a button and had all of the information that we needed on the report. But it is required that we bring it before the court, an explanation of what we do with our citations broken down by ethnic groups, whether or not a search was conducted, was consent given in the search, whether or not it was on probable cause, and that could be from an officers observation due to what he might smell or use of the canines as well, but it is required that the court receive that report to satisfy that statute.


