LOCAL GOVERNMENT CODE SEC. 111.0675*, NOTICE IS HEREBY GIVEN THAT ARANSAS COUNTY WILL HOLD A **PUBLIC HEARING ON THE 2021 TAX RATE AT 8:30AM, MONDAY, AUGUST 23, 2021** IN THE COMMISSIONERS' COURTROOM, ARANSAS COUNTY COURTHOUSE, 2840 HIGHWAY 35 N., ROCKPORT, TEXAS. THIS BUDGET WILL RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$369,338 OR 2.87% AND OF THAT AMOUNT, \$413,470.48 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.
