On the 27th day of July, 2015, there was a Regular Meeting of the Commissioners' Court in the Courthouse, Rockport, Aransas County, Texas, with the following members present: C. H. "Burt" Mills, Jr., County Judge; Jack Chaney, Commissioner, Precinct 1; Leslie "Bubba" Casterline, Commissioner, Precinct 2; Charles Smith, Commissioner, Precinct 3; Betty Stiles, Commissioner, Precinct 4; and Valerie K. Amason, County Clerk.

The proposition will raise the M&O by two cents and reduce the I&S by two cents resulting in the school being able to keep 100% of the "taxes raised" to remain in the school district and not requiring anything to be sent to the state.

REPORTS FROM COMMISSIONERS, ELECTED OFFICIALS & DEPARTMENT HEADS WHEREIN NO ACTION WILL BE TAKEN

Commissioner Chaney, suggested that it would be helpful to the court if we could show on the agenda if the item at hand is something that had been approved in the previous year and whether the item on the agenda was included in the current budget or being discussed for the next year's budget.

Commissioner Smith, indicated that he did not think that Aransas County should continue to allocate \$5,000.00 to the Shopping Tournament; understanding that it is a good cause, the real purpose

for the HOT Funds does not include generating money to transfer funds from a HOT tag over to a school beneficiary type situation.

Commissioner Stiles: We had a wonderful event Saturday with the State Congressional Committee who put together a local event that brought people in from all over the state as a means to educate the public on so many different issues. Senator Lois Kolkhorst talked about the Legislative Session. Todd Hunter talked about Human Trafficking. Congressman Blake Fahrenthold was present. Bob got to go see the two gentlemen who rescued the two other Americans from Benghazi. One important thing I learned was that Ambassador Stevenson was not dragged through the streets. One of the gentlemen found him after he had been killed, his body still intact. A lot of rumors and things reported that were not true, it was shocking.

Judge Mills: Shocking thing to me is when we were told that those two gentlemen, because they were contract people for security, they had made it home and back in the United States after being...

Commissioner Stiles: ...after holding on for 13 hours over 40 something insurgents that they came into...

Judge Mills: ...one of them being wounded so bad that he is still going through operations to correct his problems, he was shot I think fourteen times.

Commissioner Stiles: There is going to be a movie and it will be called "13 Hours in Benghazi", this will be well worth seeing.

REPORTS ABOUT ITEMS OF COMMUNITY INTEREST
REGARDING WHICH NO ACTION WILL BE TAKEN

Judge Mills: About two weeks ago Commissioner Casterline and I took the Sheriff's boat and went out to Cedar Bayou to take a ground look at it, the slough is still flowing and functioning well, the mouth is probably 200 feet wide, the deepest part is about 30-40 feet wide and anywhere from three feet to eight feet deep, so it's going well. The mouth to Vinson slough is somewhat different, it's pretty shallow but as long as the water is flowing through it, it's functional, so all the stories that you might hear, it's closed up, or its closing up, is false.

Commissioner Stiles: I got crab thumb, because we cleaned 45 crabs over the weekend. The Bayou being open is helping a bunch.

PRESS QUESTIONS

Norma Martinez, Managing Editor for The Rockport Pilot: Regarding Agenda Item #8, last year when the Court approved the \$5,000.00 for the Shopping Tournament, the question was raised that it is quite a bit of money to spend on 60 plus people coming from out of town. Will you be taking this into consideration as to how much you will be giving them? At this rate, that's more than \$70.00 per person to bring in 60 people here.

Commissioner Smith: This is the third year and it is off the ground now, we have provided seed money for it. My take on that is we should be scaling back on that at this point in time. We have other needs for money that would make a lot more sense. I know my commissioners would love to be looking for money to put in a disabled kayak ramp out in St. Charles Bay. When you start matching the benefits, these are the kind of issues we need to be putting money into in my opinion.

Norma: Regarding the budget, I was here when the discussion was made to put all the IT Service Agreements, to be considered, into an IT budget. Because the question at that point was with every department having their own IT budgeted item, whenever the court looked at it, then billed each department and worked it together to come out exactly, to try to figure out how put them back into It. The court then decided to take money from each of those budgets and put in the IT Department to create the Department itself. So, if you're going to go backwards and put IT into each budget, does that mean our IT Department funding will also go back to each of those departments?

Smith: The funding point is on the budget. I think we can have it both ways, I think having it in the department where those particular direct costs have been generated now that I'm looking at it, to measure per personnel policy. The Auditor can run a report and shift all of the IT costs onto one sheet. So we are not going keep giving up any information, we are going to be getting better information if we go with what we are talking about. It's a separate report to show what we are spending on the IT Department and spread it by costs, and she can do that.

Chaney: One of the issues, if I remember correctly now that we are talking about that, is the IT department at that time were having difficulty in getting control of who was billing and who was purchasing what. Originally, it was from a purchasing aspect, what we talked about today was leaving the purchasing with them, but to show a representative cost in the individual department as to what that particular maintenance agreement or official equipment is. Not to say we are going to change anything on the way we buy.

Casterline: I don't thing we are really talking as much about putting the money back into each department's budget, as much as we have a schedule where each line shows how much is allocated out of each department's budget.

Smith: Norma, please keep in mind, this budget is an operating plan, and not set in stone. This is the point I was making today, when I found out that something had already been purchased without being approved yet. We have the responsibility of making sure that those things, as we go along, have more and more information. The fact that it's in the budget does not mean that it's your money and you can spend it any way you wish, it just does not work that way. As a matter of fact, maybe somewhere in the future, we ought to go back to a zero based budgeting, which means that we a build a department from the floor up because, after a long time, what happens is, you'll find, "Ok, I'm just going to increase my budget by five percent". There is no real attempt to go in and determine if they really need it. I'm not suggesting we have people that are doing a bad job, but it would be a delightful action to take, to try to justify exactly where we are.

Norma: Concerning the combined County/District Attorney position, can you tell me where in the Budget that is and if it's going to cost \$170,000.00, but yet we were only paying \$135,000.00 previously.

Smith: There is a separate line item for District Court where it shows how much we were contributing.

Casterline: Plus you know the state will pay the District Attorney.

Smith: But that's not included in our Budget for the District Attorney for this year anyway, for 2016.

Lezlie Kirk: It will be County and District Attorney in next year's budget and right now is on Page eighteen. It still is a work in process, we are still working on salaries, decisions, costs, and so this one will be changing, but I put the numbers out here in red, that this is what was turned in.

Smith: Now keep in mind that that \$134,000.00 and some odd dollars that went to the DA last year; that number was going to go up this year. They have the same problem over in San Pat County in staffing, as everybody else does, that thing probably would have increased ten to fifteen thousand dollars this year or more, including staff. I guarantee you that if we had not been able to get it we would be paying probably close to \$150,000.00 this year for that DA fund.

Norma: When you started paying management, did you still have to hire staff, court reporters and etc.

Smith: There will be added costs, probably about twenty five to thirty thousand dollars.

Norma: I think it will probably be more than that.

No further business presenting, the Court adjourned at 11:20 a.m. on a motion made by Commissioner Smith duly seconded by Commissioner Casterline.
