County Clerk Friebele reported she will be having a right knee replacement on Friday and will be out for several weeks recovering. Commissioner Chaney reported he will be having a heart stint put in tomorrow and will be on light duty for several weeks.

Commissioner Stiles reported the turnout for Lamar Days was lower than previous years and this will be the last "garage" sale type of fund raiser they will be having. There will still be Lamar Days but the format will be different.
