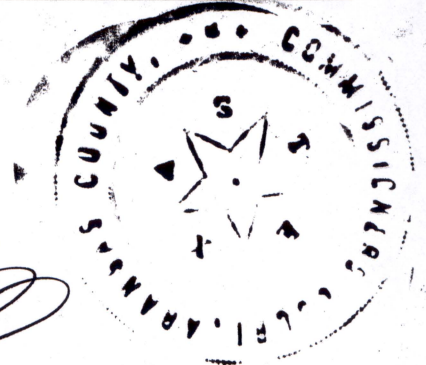

ITEMS FOR DELIBERATION AND/OR ACTION

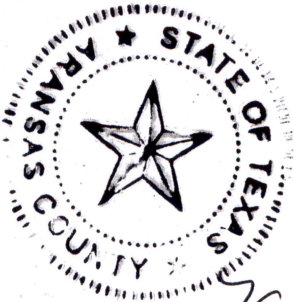
