Notice is hereby given that the Aransas County Election Board will convene on the above date at 9:00 a.m. in the 2<sup>nd</sup> Floor Conference Room of the Aransas County Courthouse, located at 301 N. Live Oak St., Rockport, Texas, 78382 to consider the following:

**3. Items for Deliberation and/or Action**

- a. Discuss, approve or disapprove the Proposed Minutes from the County Election Board meeting held on October 9, 2024.
- b. Discuss, approve, or disapprove authorizing the Elections Administrator to procure the election supplies necessary to conduct the November 3, 2026 General Election and determine the quantity of the various types of supplies to be provided to each precinct polling place and early voting polling place. (TEC, Sec. 51.003)
- c. Discuss, approve, or disapprove appointing the Presiding Judge and Alternate Judge of the Early Voting Ballot Board for the November 3, 2026 General Election. From the lists as submitted by the Democratic and Republican Party Chairs. (TEC, Sec. 87.002(d))
- d. Discuss, approve, or disapprove appointing members of the Early Voting Ballot Board for the November 3, 2026 General Election. From the lists as submitted by the Democratic and Republican Party Chairs. (TEC, Sec. 87.002(c))
- e. Discuss, approve, or disapprove, appointing all Deputy Early Voting Clerks—appointed by the Early Voting Clerk from the lists submitted by the Democratic and Republican Party Chairs for that purpose—to the Early Voting Ballot Board for the purpose of conducting the Post-Election Hand Count Audit (PEHCA) for the November 3, 2026 General Election, in addition to the clerks appointed under item “d” above. Clerks assigned to perform the PEHCA shall maintain party balance, and the total number shall not exceed the maximum ordered by the County Commissioners Court. (TEC, Secs. 127.201(b-1) and 87.002)
