THE ISSUANCE OF GENERAL OBLIGATION BONDS IN THE PRINCIPAL AMOUNT NOT TO EXCEED \$17,235,000 TO CONSTRUCT A COUNTY COURTHOUSE AND FOR THE COSTS OF ISSUANCE OF THE BONDS; AND THE LEVY OF A TAX IN PAYMENT THEREOF.
